CONSTRUCTION & FALL PREVENTION

Recommended Courses:

Accident / Incident Investigation Cal/OSHA* – This course covers investigation process requirements in Title 8 3203 that should be used as part of your IIPP.

Basic Construction Safety Cal/OSHA – Basic overview of the hazards in construction work, and an overview of associated Cal/OSHA standards.

Heat Stress - In California, preventing Heat Illness is extremely important for employees that work both indoors and outdoors. This course reviews how heat affects the body, the steps that employees can take to prevent heat stress, and elementary first aid that can be given to a worker who has been affected by a heat-related illness.

Injury and Illness Prevention Programs (IIPP) – Not having an IIPP is the most cited Cal/OSHA standard, and it is a critical element to a healthy safety culture.

Job Hazard Analysis for Supervisors Cal/OSHA – This course covers the appropriate methods and steps for Job Hazard Analyses (JHAs).

Ladder Safety Cal/OSHA* – Basic ladder safety, including ladder selection, and safety procedures. This course covers Cal/OSHA Title 8, Subsection 3276(f)

25m

Lockout/Tagout Safety Cal/OSHA - This course covers preventing the release of hazardous energy (electrical, kinetic, etc.), and how to comply with related Cal/OSHA standards.

9m

Preventing Slips, Trips, and Falls Cal/OSHA – This course covers Cal/OSHA standards relating to falls. Slips, trips, and falls are among the leading causes of fatalities at work.

Safe Lifting Strategies – State Fund Ergonomists' Elizabeth Kihm and Sharon Snarr share how important it is to lift safely and provide some great tips to prevent injuries.

State Fund's Scaffold Safety Course - In this course, participants will review Cal/OSHA requirements for scaffolds and learn how to recognize unsafe scaffolds.
